WaiPlenty Repeater Network - News

Te Weraiti '695 made it back on the air around midday on Thursday 11 August thanks to a contractor visiting the site for other work, however failed again about a week later. Its battery charger had failed, and our battery run down to only a few volts. The '695 repeater and associated link to Te Uku are on emergency antennas following failures and damage discovered at the beginning of May. Complete re-rigging of the mast is planned to hopefully occur over the coming summer, restoring '695 and its links to original performance we enjoyed. While that takes place, the whole installation there will operate on temporary antennas, resulting less overall coverage. A replacement battery has been donated, to be installed along with a new higher specification battery charger (capable of working with multiple battery technologies as well as having conformal coated printed circuit boards to protect against moisture ingress) and a Low Voltage Disconnect. Materials to get '695 and its associated links back on the air is costing the VHF Group about \$900 (equivalent to 1.5 times the number of subscriptions paid in 2022).

The faulty battery charger ex Te Weraiti has been repaired and refurbished by the manufacturer's service department, and will be retained by the VHF Group as a spare for Te Uku (where two of that model are used) and Maungakawa (where one is used).

Maungakawa has a long standing interference issue impacting '5575, caused by intermodulation between multiple transmitters there. Calculations (involving 1000's of

potential products) identified ten of the 47 VHF and UHF transmitter frequencies on site as possible suspects. Those have been monitored in an effort to identify which are transmitting simultaneously while '5575 is being interfered with. That interference has occurred intermittently, and infrequently while monitoring for it, (a watched pot scenario!). At the time of writing this newsletter note, the particular combination of transmitters involved as the source has been potentially narrowed down to three. How to deal with that is now being worked on, and will eventually involve making a 4WD 120km round trip to the site to implement.

Rather than noise up the other repeaters in our WaiPlenty network each time this interference at Maungakawa impacts, '5575 has been isolated from the rest of the network for the time being. Once the interference issue is proven and resolved, '5575 will be joined up to the WaiPlenty network again.

Our Te Uku '5675 repeater may be used by operators for the Rally of New Zealand running from 29 September through to 2 October. The main day for activity on '5575 will be Friday 30 September while they're in the Te Akau to Raglan area. For that day, '5675 will be made stand-alone (isolated from the rest of the WaiPlenty network and IRLP).

Who funds our repeaters?

The WaiPlenty 2-metre repeater network along with National System repeaters at Kaimai and Hamilton are funded and operated by the Waikato VHF Group Inc. These facilities don't run on fresh air, but rely on funds derived from membership subscriptions and donations to keep them on the air. Annual expenditure includes 14 radio licence fees, electricity and site access payments plus maintenance costs, which last year exceeded \$2000.
